**Merit List & Instructions for IPM NALSAR-2023 Counseling**

- 30% (19 seats) Horizontal reservation shall be applicable for Female candidates for admission to BBA, MBA (Integrated Management Programme-IPM).
- 05% {03 seats for BBA,MBA program} Horizontal reservation shall be applicable for Persons with Benchmark Disabilities (PWD).
- Three additional candidates may be admitted over and above the sanctioned intake under All India General Category every year for BBA-MBA program through CLAT(UG)/IPMAT(IIM, Indore)/IPMAT(IIM, Rohtak) /JIPMAT(IIM, Jammu & Bodhgaya)/JEE (Mains) to meet the future vacancies due to withdrawal of candidates after admissions.
- **20% (13 seats) shall be allocated to Foreign National category over and above the sanctioned strength.**

If a candidate belonging to reserved category (vertical reservation category) qualifies for admission under Unreserved category as per merit, then the candidate shall be considered against the Unreserved category seat only and not against the reserved category seat.

## **DOCUMENTS REQUIRED FOR RESERVED CATEGORIES AT THE TIME OF DOCUMENT VERIFICATION AT NALSAR**

### **For Candidates seeking admission under the OBC-NCL category**

OBC-NCL certificate should have been issued on or after April 01, 2023 in consonance with the latest guidelines of the Government of India. If any OBC-NCL candidate fails to submit the OBC- NCL certificate (issued on or after April 01, 2023) at the time of document verification at NALSAR, the provisional admission offered shall stand automatically cancelled.

### **For Candidates seeking admission under the General EWS category**

EWS certificate should have been issued on or after April 01, 2023 in consonance with the latest guidelines of the Government of India. If any EWS candidate fails to submit the EWS certificate (issued on or after April 01, 2023) at the time of document verification at NALSAR, the provisional admission offered shall stand automatically cancelled.

### **For Candidates seeking admission under the Resident Student of Telangana reserved categories**

The candidate seeking admission under SC / ST category under Resident Student of Telangana category should submit their relevant certificates issued by Government of Telangana as per the latest guidelines.

The candidates seeking admission under BC-NCL category under Resident Student of Telangana category should submit the BC certificate issued by Government of Telangana specifying the categorization under BC-A, BC-B, BC-C, BC-D and BC-E as per the latest guidelines of the Government of Telangana. The Non-Creamy Layer certificate should have been issued on or after April 01, 2023 in consonance with the latest guidelines of Government of Telangana. If any BC (NCL) candidate fails to submit the NCL certificate (issued on or after April 01, 2023) at the time of document verification at NALSAR, the provisional admission offered shall stand automatically cancelled.

The candidates seeking admission under EWS category under Resident Student of Telangana category should submit the EWS certificate issued by Government of Telangana on or after April 01, 2023 in consonance with the latest guidelines of the Government of Telangana. If any EWS candidate fails to submit the EWS certificate (issued on or after April 01, 2023) at the time of document verification at NALSAR, the provisional admission offered shall stand automatically cancelled.

## SEAT CONVERSION POLICY

**Conversion policy for vacant seats of various categories:** The flow chart for conversion of vacant seats of various categories shall be as indicated below:

- All India S.C. → All India S.T. → All India Unreserved
- All India S.T. → All India S.C. → All India Unreserved
- All India OBC-NCL → All India Unreserved
- All India EWS → All India Unreserved
- Resident Students of Telangana Unreserved → All India Unreserved
- Resident Students of Telangana S.C. → Resident Students of Telangana S.T. → All India S.C. → All India S.T. → Resident Students of Telangana Unreserved → All India Unreserved
- Resident Students of Telangana S.T. → Resident Students of Telangana S.C. → All India S.T. → All India S.C. → Resident Students of Telangana Unreserved → All India Unreserved
- Resident Students of Telangana BC-NCL → All India OBC-NCL → Resident Students of Telangana Unreserved → All India Unreserved
- Resident Students of Telangana EWS → All India EWS → Resident Students of Telangana Unreserved → All India Unreserved

Wednesday, August 9, 2023	Declaration of Second List of provisionally selected candidates from Waiting List. (Only candidates registered for the counseling will be considered)
Sunday, August 13, 2023	<p>Deposit of Rs.1,50,000/- by the provisionally selected candidates of <b>Second List</b>.</p> <p>An acknowledgement receipt will be generated and the copy of the receipt must be mailed to <a href="mailto:doms@nalsar.ac.in">doms@nalsar.ac.in</a> for record and completion of the provisional admission process.</p>
Wednesday, August 16, 2023	Last date for the payment of balance of full fee

Note: The Candidates are advised to check their registered mail account for correspondence (Please check Spam and Promotion Folders as well). The University shall not be responsible for non-delivery of Email or SMS

1. Candidates are advised not to wait till the last minute to make payments to avoid payment related issues. University will not be responsible for any issues relating to payments. You must wait till you see a 'Payment Successful' message. Requests to make payments after last date due to transaction failures or other issues will not be considered.
2. Only those candidates who successfully complete the counseling registration process will be considered for allotment of seat.
3. Candidates who do not complete / participate in the counseling registration process will not be considered for allotment of seat.
4. Mere registration for the counseling will not guarantee you a seat.
5. Candidates who have not received invite for the counseling process in the first round may be called during subsequent rounds, in case vacancies, if any, arise in any particular category.
6. If a candidate features in any provisional list and withdraws, he/she will lose his/her current allotted seat and will not be considered for allotment in the subsequent lists also. **Such candidates will not be issued any refund.**
7. The University reserves the right to announce further invites to register for the counseling and subsequent lists of provisionally selected students, subject to vacancy, if any.
8. If a candidate registered for counseling does not get a seat after the release of Provisional Lists, total amount of Rs. 50,000/- will be refunded to them without any deduction.
9. If a candidate is found ineligible based on the documents / information provided by him / her, an amount of Rs. 40,000/- will only be refunded.
10. The said refund will be initiated by the University after September 10, 2023 or on completion of admission process.
