Procedure for Offering Admission

The Expression of Interest (EOI) form will be sent to candidates in the rank list. Candidates must complete the Expression of Interest registration by paying the counselling fee of ₹1,00,000 (Rupees One Lakh only) within the stipulated time period of **one week** from the date of receiving the EOI communication.

Upon successful submission of the Expression of Interest form and payment of the counselling fee, provisional admissions would be offered as per the seat matrix applicable to the program. The payment of counselling will not always mean provisional admission. In such cases, the counselling fees would be refunded.

The candidates who are offered provisional admissions are required to pay an additional amount of ₹2,00,000 (Rupees Two Lakhs only) on or before **June 12, 2026**, towards confirmation of admission. Failure to pay the required amount within the stipulated time will result in the automatic cancellation of the provisional admission offer. The remaining amount of **Rs 1,47,000** (Rupees One Lakh forty thousand only) has to be paid by June 19, 2026.

In the event that seats allocated for Phase 2 remain vacant, additional Expression of Interest forms may be issued to candidates from the **waiting list** after one week from the issuance of this rank list, in order to fill the remaining seats in accordance with the seat matrix.
